## Reporting Racism in Health Care

In the recently released report "[In Plain Sight Addressing Indigenous Specific Racism and Discrimination in B.C. Health Care](#)" it is clear that the health system has work to do in order to provide culturally safe and competent care for the Indigenous peoples of BC.

This report lays out a series of recommendations for government, health authorities, regulatory bodies, associations, educational institutions and unions to undertake as part of a concerted effort to eliminate racism within the system. NNPBC will work with our members and partners to action the recommendations that fall to us to enact. We will also support our members and partners to do the same.

In an effort to help our members, partners and the public understand what resources are available to them in support of achieving these recommendations, NNPBC is pleased to share the following information:

### Reporting

NNPBC fully respects that many may have hesitation about formally reporting their experiences within health care, but we do want to ensure that everyone is fully aware of the following options available to report racist experiences in health settings.
