### Summary of Revisions

Minor editorial changes have been made to clarify the conditions within the scope of practice that Registered Nurses can manage with certified practice designation in RN First Call and Remote Nursing.

The assessment DST document numbers have been revised to differentiate DSTs for each certified practice designation, with the addition of letters 'FC' (First Call) and 'REM' (Remote Nursing) to clearly delineate between assessment DSTs for each certified practice area.
