### 1. Call to Order

The Annual General Meeting of the Association of Nurses and Nurse Practitioners of British Columbia was called to order at 10:06 am.

- The Chair introduced the virtual Head Table as well as special guests.
- A moment of silence was held for those nurses who passed away this past year.

### 2. Appointments

### 3. Notice of the Annual General Meeting
